REQUIREMENTS FOR NAME/ADDRESS CHANGE

- Account number and or meter number <u>must</u> correspond with the database.
- In the case a change in name on the account, a refundable deposit is to be paid by the tenant before the transaction is completed.
- If the form is signed by anyone other than the owner, the agent or landlord <u>must</u> submit a letter from the owner authorizing the agent or landlord to act on his/her behalf.
- A Final Reading form <u>must</u> accompany this form if there would a change of tenants or sale of property and or change of ownership.
- Balance on a/c must be \$0.00 for the name to be change
- There are **three sections** to be filled out before submitting to NEVLEC:
 - 1. Present a/c holder
 - 2. New a/c holder
 - 3. Owner/agent/landlord
- Proof of ownership or power of attorney <u>must</u> be presented. If none of these documents are available then the letter of agreement <u>must</u> be signed and attached to the completed form
- A <u>valid</u> ID must be presented for the new account holder (*Passport, Driver's license, Social Security, Work Permit*)
